A. Title Five: Rule 900 (ICAPCD)

RULE 900 AMENDMENT & TITLE V UPDATES

- **Imperial County Air Pollution Control District is currently working on possible amendments to Rule 900 removing Affirmative Defense Provisions due to US Court of Appeals decisions. The Air District is working on holding informational workshops with various stakeholders and the public. Final actions updating the rule will be pending finalization of any litigation and receiving guidance from the US EPA.**

1990 - Clean Air Act (CAA) Amendments Established Title V of CAA



1992 - First Promulgation of Affirmative Defense Provision



2001 - USEPA approved 34 Air District's Permitting Programs including Imperial County APCD



2011 - ICAPCD Rule 900 revised for GHG levels (submitted to EPA but not acted on)




2016 - USEPA proposed rule to remove emergency affirmative defense from Title V



USEPA determined the affirmative defense provisions in their programs was inconsistent with their interpretation of the enforcement structure



Given the court's decision USEPA decided to review other programs



2014 - US Court of Appeals vacated affirmative defense provision in the USEPA's hazardous pollutant regulations for the Portland Cement Industry



2018 - USEPA withdrew proposal to remove emergency affirmative defense



2022 - USEPA submitted new proposal under the same title to remove emergency affirmative defense



2023 - USEPA removed emergency affirmative defense provisions from Title V



2023 - ICAPCD Withdrew 2011 Rule 900 Revision as EPA Title V Rule



2025 - US Court of Appeals reversed the recission of the emergency affirmative defense from Title V

AIR DISTRICT ACTIONS

• Steps completed

- Air District has begun analyzing possible changes to Rule 900 Language and possible changes to Title V Permit Language
- Air District has requested Cities provide member contacts for an Advisory Board for local jurisdiction input
- Cities have designated members to sit on the Advisory Board and Air District has provided information regarding Advisory Board
- Air District has begun holding informational workshops to Title V Permit Holders/Facilities
- Air District has begun providing informational updates to members of the public

• Future Steps

- Air District will begin scheduling workshops with Advisory Board members
- Air District will schedule additional public information workshops including various stakeholders
- Air District will prepare proposed language changes and staff report to be presented to Air Pollution Control District Board
- Air District will remain in communication with EPA for final guidance for compliance with final legal decisions







Calipatria Unified School District: Transportation Yard & Access Road







Brawley Elementary School District: Barbara Worth Jr. High Parking Lot








Brawley Union High School District: District Warehouse Parking Lot







Brawley Union High School District: District Offices & Athletic Compound Parking Lot







City of Calipatria: Freeman Street






City of Westmorland: 1st Street










City of Westmorland: City Hall Parking Lot
