HEBER TOWNSITE IMPROVEMENT - PHASE 1 UNDERWAY





Heber, CA (January 24, 2024) - The ICAPCD, in conjunction with Imperial County Public Works, hosted a groundbreaking ceremony for various road improvements in unincorporated Heber, CA. The project consists of construction of infill street pavement, bike lanes, sidewalks, and more in this community. The Community Steering Committee identified this project as a direct way to reduce particulate matter from roadway traffic. Approximately \$2.4 million of AB 617 funds were appropriated for this community project, and construction is anticipated to be complete by the end of April 2024. Phase 1 will immediately reduce emissions for this disadvantaged community.

COMMUNITY AIR MONITOR LOCATIONS SELECTED, IST INSTALLED





Westmorland, CA (February 26, 2024) - The North-End Community installed its first community air monitor in residential-zoned Westmorland, CA. With the work of SCS Engineers, this monitor is a first step of the Community Air Monitoring Program which identifies areas with high levels of particulate matter for residents. In the coming months, the North-End Committee will identify an additional fourteen monitor locations throughout Brawley, Westmorland, and Calipatria. The boundary lines were finalized during an April 2024 special meeting, and will now guide the North-End Committee on its placement of these monitors in rural and suburban regions.
